#### Document Cases, Available in Tan, Blue/Gray, Black, and Perma Dry (water repellent)



An archival storage standard, these boxes are metal edge constructed from durable 60 pt. acid-free board and buffered with 3% calcium. The interior is lined in white paper and measures a pH of approximately 8.5. The metal edge we use to construct our boxes offers more "grips" per inch than many other manufacturers, creating a stronger, more durable box. Larger (5") boxes feature a black nylon cord loop that allows easier removal from shelving. Perma Dry, a water repellent version of the boxes, comes in Blue/Gray.

#### Unreinforced and Reinforced File Folders



These File folders are made from acid-free, lignin-free 10 pt. Perma/Dur stock for exceptional strength and endurance. The folders are buffered with 3% calcium. The *Unreinforced* File Folders have a top margin of .5" exposed tab, straight cut and round corners and is available in third, half, and full cut tab. The *Reinforced* File Folders come in .5" and 1" full cut exposed tab. They are available in two lightfast, non-bleeding, soil resistant colors.

#### **Buffered and Unbuffered Acid-Free Interleaving Tissue Paper, 10#, 16 gsm**



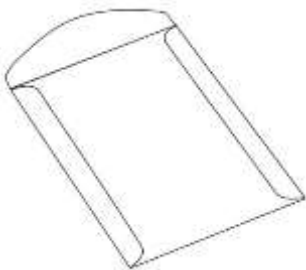

#### **Buffered and Unbuffered Perma/Dur Negative Envelopes - With and with Out Thumb Cut**



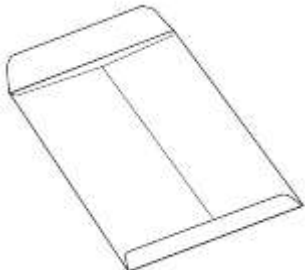

These envelopes have two side seams that are not only safer, but provide more even stacking and filing in large groups than the center seam.
